



Facilities			<ul style="list-style-type: none"> <li>CertaSite, a portfolio company of The Riverside Company, has acquired Heartland Fire &amp; Security ("HLFS"), a Davenport, IA based fire protection and security business</li> <li>HLFS offers a broad range of fire safety and security services including the installation and maintenance of fire alarms, fire suppression systems, security systems, CCTV systems and safety systems to industrial &amp; commercial facilities</li> <li>The acquisition of HLFS is Certasite's 17th Midwest based fire protection and life safety add-on acquisition to their platform, which further expands their customer pool and service options</li> </ul>
Industrial		<p><b>One Equity Partners</b></p> 	<ul style="list-style-type: none"> <li>Buckthorn Partners, a British private equity firm, has teamed up with One Equity Partners ("OEP"), a U.S. private equity firm, to propose an offer to acquire British civil engineering firm, Amey from Spanish infrastructure firm Ferrovial for ~\$240 million</li> <li>Amey, with its network of ~15,000 employees, is one of Britain's largest private civil engineering contractors that works across various sectors including prisons, schools, transport and defense</li> <li>Buckthorn and OEP's acquisition of Amey is a strategic effort for the private equity firms to dip into recurring government spending and major projects</li> </ul>
Distribution			<ul style="list-style-type: none"> <li>Reladyne, an American Industrial Partner's portfolio company, has acquired Orange Line Oil Company ("Orange Line"), a distributor and wholesaler of lubricants, solutions and coolants</li> <li>Orange Line is one of California's largest distributors of bulk motor oil and a steady wholesale distributor of coolants, solutions and other vehicle based products for automotive care shops and commercial garages</li> <li>Reladyne will look to take advantage of Orange Line's customer base, distribution channels and product lines to help build out extensive penetration into the California oil distribution markets and to catalyze sustainable growth for new product offerings through the Reladyne name</li> </ul>
Logistics			<ul style="list-style-type: none"> <li>USA Truck (NASDAQGS:USAK), a Van Buren, AR based transportation services provider, has been acquired by BD Schenker, Inc., the logistics division of German Rail Operator Deutsche Bahn</li> <li>USA Truck, through its two divisions Trucking and USAT Logistics, provides all of the services required to haul, track and deliver freight across North America</li> <li>The \$435 million (~\$32 per share) acquisition will securely position DB Schenker as a major player in the land transportation industry as they acquire access to more than 2,750 tractors and 6,500 trailers</li> </ul>
BPO			<ul style="list-style-type: none"> <li>Empower HR ("Empower"), a professional employer organization ("PEO") and human resources outsourcing firm, has been acquired by Vensure Employer Solutions ("Vensure"), a portfolio company of Stone Point Capital</li> <li>Empower offers a full suite of PEO and HR services through a web based portal to benefit a variety of industries including private equity, technology, healthcare and hospitality in the Midwest</li> <li>Vensure will look to leverage the acquisition of Empower to provide a more encompassing array of support offerings to clients as the firm tackles its next phase of growth</li> </ul>


Enterprise Value / LTM Revenue




Enterprise Value / LTM EBITDA



LTM Revenue Growth




LTM Gross & EBITDA Margins\*
